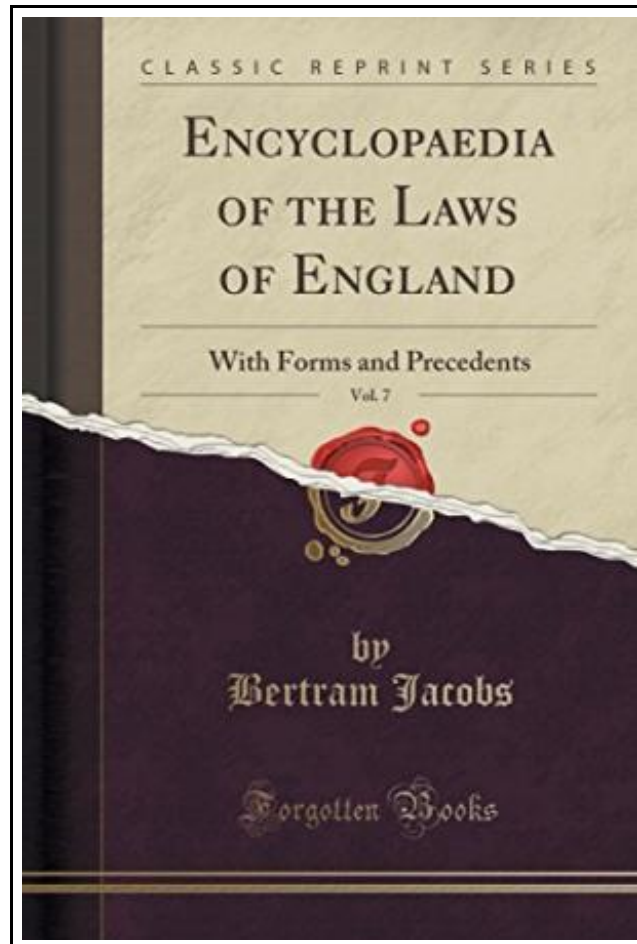

Collateral facts not otherwise relevant are admissible to show the identity of a person accused of crime or to rebut an alibi (Taylor, ss. 336, 337). Presumptions in favour of identity are made from identity of name or from replies in correspondence (Taylor, ss. 1856-1860). Goods. - In the case of goods, if a question of identity arises it is usual to produce the articles in Court and let the jury judge by their own senses; but witnesses may be called who have seen the goods and can give their opinion as to whether they are the goods in question (Taylor, ss, 555a). Where in an indictment an allegation is made descriptive of the identity of some thing, it must as a general rule be proved as made subject to the power to amend (14 15 Vict. c. 100, s. 1), where the discrepancy between allegation and proof is not essential (Archbold, Cr. Pl., 23rd ed., 300). Documents. - Where identification of a document depends on questions as to handwriting, the evidence admissible is that of a man who knows the handwriting of the person alleged to have written or signed it or who is an expert in or experienced in handwriting, and comparison of authentic writings of the supposed writer is permitted (see 28 29 Vict. c. 18, s. 8; R. v. Silverlock, [1894] 2 Q. B. 766; Taylor,...
